

# Will Writing Guide





It is important for everyone to have a professionally drafted Will, one that you can be certain will be legally valid when you die.

#### **Executors:**

An executors' main priority is to handle every single thing once you pass away. An executor's legal obligation is to carry out any desires you may have in accordance with your will. It would be beneficial to think of a backup executor in case your first choice is unable to execute. Executor's may be required to contact/ submit documentation with the Probate Courts, banks, HMRC, the Land Registry, utility companies, and more.



### **Professional Executors:**

#### **Guardians of Children under 18:**

Many clients may have younger children under the age of 18; if something were to happen to you, your children might be taken into the care system until a decision about their future is made if you do not delegate appropriate guardianship.

Consequently it is a primary concern – designating guardianship within your will eradicates any risk.



## Specific Gifts:

Specific assets of financial or personal worth can be gifted, these might range from your own children, grandchildren or even to a local hospice and are frequently very appreciated.

#### Gifts of Residue:

Gifts of residue are the balance of your estate, which includes anything you haven't expressly donated. You are free to split your estate anyway you see fit. You may want to add ages for assignees to obtain at times (like upon reaching a certain age). This can include: real estate and land, any finances left in accounts, sentimental goods and assets etc. As the will writer, you are free to segment your assets in any way you may wish. It is also recommended that you plan ahead of time for any residual presents.





Another important aspect to contemplate is your present status. Any of the following big life events, may lead you to you rewrite your will:

- A fresh addition potentially a new grandchild.
- Relocation.
- Divorce or marriage.
- Property Inheritance.
- Executors death.
- Changes in legislation regarding your will.





#### Trusts:

A trust may be applicable if you have children from a prior relationship or if you want to donate your estate with limitations. You are able to set up a trust and delegate duty to trustees if: a beneficiary is untrustworthy with finances, disabled, or not old enough to inherit. Please contact us to discuss your alternatives.

## Lasting Power of Attorney:
